

Children's Institute's biennial Community Update and Coterie Award presentation

In October, Children's Institute hosted our biennial Community Update at the Genesee Valley Club. This forum invites community members to learn more about selected Children's Institute programs. This year's main presentation was entitled, "Looking Beyond a Crystal Ball to Predict Student Success" by Guillermo Montes, Ph.D., Director of Research and Evaluation.



In addition to his work with Children's Institute, Guillermo is also an Associate Professor at St. John Fisher College. He has authored numerous research papers, chapters, and a book entitled, "Unmet Needs: Child Care for Children with Autism in the United States." His primary interests include the use of large national datasets to measure social competence and other elements of emotional intelligence, particularly in at-risk subpopulations, such as children with autism spectrum disorders.

IBM has provided a grant valued at \$20,000 to support Children's Institute's research for organizations that serve children in our community. The Impact Grant for SPSS licenses received from

IBM will ensure an improvement in the models gathered from the research. Children's Institute would like to thank IBM for the use of this technology and ongoing support.

The research and evaluation team at Children's Institute uses a range of established research methods, and depending on needs, designs and studies new approaches to problems confronting schools, children, caregivers, families, and physical and mental health service providers. Our goal is to ensure that children's problems are identified sooner, access to effective interventions is available, and accurate and current data is provided to policymakers who make decisions for children.

A note from the director

Children's Institute is wrapping up a big year...and we're expanding our reach even more next year.

We're actively participating in the Monroe County Anti-Poverty Initiative which has been sharing their vision of how to make meaningful changes to address Rochester's poverty crisis. Children's Institute's expertise in data collection and evaluations will be a critical piece when setting up programs that will have measurable goals, and more importantly, change lives. Just to recap, the goals of this initiative are to reduce poverty by 50% in 15 years and increase the number of families who are self-sufficient.

We rolled out a new fundraiser this fall called KIDS & TRUCKS. This event allowed children and their families the chance to "climb aboard and explore" all different types of vehicles. We saw children's imaginations at work and feel that this event will help raise awareness of who we are, what we do in the community, and help raise additional funds to support programs that impact children's lives. Watch for information on next year's event when we hope to have more kids and more trucks!

Our biennial Community Update was held in October and featured Guillermo Montes, Ph.D., Director of Research and Evaluation, who presented, "Looking Beyond a Crystal Ball to Predict Student Success." A suburban school district in Upstate New York provided Children's Institute with 10 years of student data for its current 10th graders, as well as the district's criteria for success. Although school districts have a great deal of data, it is difficult for them to analyze it on a macro level and determine what factors could be strongly predictive of academic

outcome. Thanks to a technology grant from IBM, we are now expanding our research capabilities and look ahead to more projects next year and beyond.

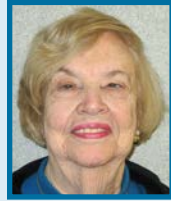

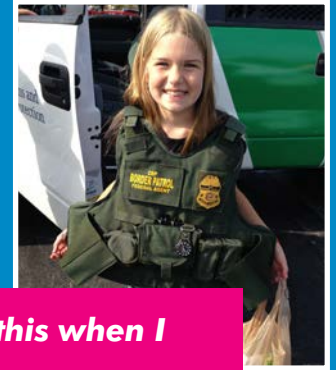


CLIMB ABOARD AND EXPLORE!
